## QUALIFYING REQUIREMENTS

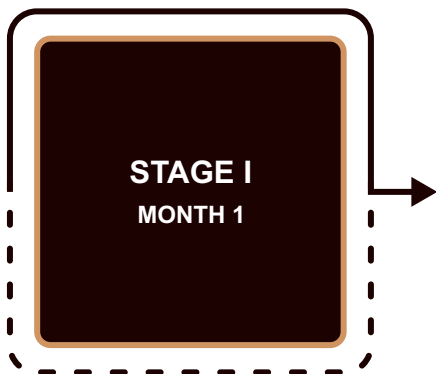
Investors looking for Greece residency by investment must fulfil some of the basic requirements for residency.

- Clean criminal record
- Certificate of health from a Greek medical professional and medical insurance to cover any length of stay in Greece
- Entry visa obtained from your local Greek consulate



## STEPS AND TIMELINE

The following table breaks down the application process into basic steps. Each step must be completed before continuing to the next.



### STEP 1

Travel to Greece with a Type 'D' (Travel) Visa

### STEP 2

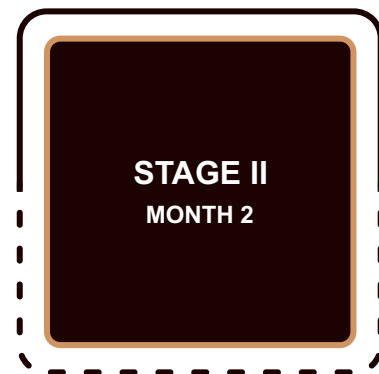
During your stay, tax number is issued along with bank account, transfer of funds, viewing properties and sign PoA

### STEP 3

Finalize purchase and acquire the property title

### STEP 4

Prepare for Residency Permit application and collect required documentation. Payment of fees is applicable at this stage



### STEP 5

Submit biometric data

### STEP 6

Once application is approved, Residence Permit is issued

## APPLICATION FEES

Application public fee	€2000
Application fee per additional member over 13 years old	€150
Translator fees	€300
Issuance of Residence Permit	€16
Issuance of health insurance policy (varies with the number of family members)	€150 - €700
